## 4 - Preparing and submit FP7 proposals

FP7 is the short name for the Seventh Framework Programme for Research and Technological Development. **FP7 is the EU's main instrument for funding research in Europe** and it will run **from 2007 to 2013**. FP7 is also designed to respond to Europe's employment needs and competitiveness. FP7 supports research in selected priority areas - the aim being to make, or keep, the EU as a world leader in those sectors. FP7 is made up of 4 specific programmes: **Cooperation**, **Ideas**, **People**, **Capacities**, plus a fifth specific programme on nuclear research.

**Research – Participants' Portal** - The Participant Portal is the entry point for electronic administration of EU-funded research and innovation projects, and hosts the services for managing your proposals and projects throughout their lifecycle. Currently the portal covers mainly actions under the 7th EU-Framework Programme for Research and Technological Development (FP7). In the future, its coverage will be extended to other programmes in the area of research and innovation.

**Register your organization** – Steps to register your organisation - Data once and receive a **Participant Identification Code** (PIC) used in the process of electronic proposal submission and negotiation.

#### **HORIZON 2020**

The proposed Framework Programme for Research and Innovation, which will be introduced post-2013, will build upon the successes of the current Framework Programme for Research (FP7), the Competitiveness and Innovation Framework Programme (CIP) and the European Institute of Innovation and Technology (EIT).

The ultimate aim is to maximise the contribution of EU funded research and innovation to sustainable growth and jobs and to tackling the grand challenges facing Europe – for example climate change, energy and food security, health and our ageing population.

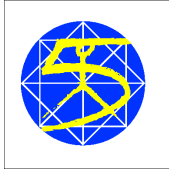
